Serving as your representative in Congress is an honor and a privilege. As the year draws to a close, I want to express my gratitude, share some of the work I've done this year, and highlight the work that lies ahead.

My focus has always been on working across the aisle to find consensus and deliver for our community. While Congress cannot solve every problem that exists, we can – and should – work together to create opportunity for everyone, lower costs, and strengthen our economy. That's why 70% of the bills I introduced and cosponsored this year had support from both parties.

My team of constituent advocates and I have also been busy helping Greater Lehigh Valley residents resolve federal issues involving Social Security, Medicare, the VA, Passports, and more. In 2023, my team and I closed cases for more than 4,170 Pennsylvanians and recovered over \$10,382,988.11 in money and benefits owed to our constituents by the federal government! I have worked to bring down health care costs since my first day in Congress. I am proud that this year we reached a major milestone: thanks to the Inflation Reduction Act that I pushed to pass, Medicare is now empowered to negotiate lower prescription drug prices for seniors and is currently negotiating fair prices for the first group of ten drugs that treat diabetes, asthma, heart disease, and more. These price reductions will save taxpayer dollars and combat decades of pharmaceutical industry price gouging. I will not stop working until everyone gets the advantage of these lower prices.



This year, we started to see the payoff of investments in our aging infrastructure, thanks to the Bipartisan Infrastructure Law that I worked hard to pass. Our own Lehigh Valley International Airport saw a huge modernization this summer, making travel smoother and serving as a key economic driver for our community. Thanks to this law, more than \$395 million in federal highway funds are coming to PA-07 to support 150 new projects to fix our roads, highways, and bridges.

Despite chaos in Washington this year, I remain focused on solving problems and delivering for our community. I look forward to continuing the fight for our shared priorities in 2024: reducing costs across the board, building a system of more affordable child care, expanding mental health care, and protecting reproductive freedom.

I look forward to another productive year serving Greater Lehigh Valley small businesses, veterans and families, and I hope you'll stay connected.
