It's been a busy week in Washington, D.C. and back home in the Lehigh Valley! Today, I was thrilled to welcome President Biden to the Lehigh Valley to show him the incredible contributions our small businesses and workers make to our local economy. I've been fighting in Congress to bring federal investments back to our community, and it was a pleasure to show President Biden how those investments are paying off and share with him our vision for the future.

Along with pushing to bring federal funding to our community, I've also continually advocated for policies that protect our children and set them up for bright futures. I'm proud to have been named a Defender of Children by First Focus Campaign for Children. And I know the work isn't over yet – in the face of rising costs and attacks on access to health care, education, and child care, I'm committed to continuing to push for legislation that prioritizes the wellbeing of the youngest members of our community.

I'm also continuing to push for legislation that ensures all Americans can access and afford the medical care they need. Did you know that surveillance colonoscopies can help reduce the risk of colorectal cancer by nearly 50%? Rep. Wild Calls for Extension of Affordable Connectivity Program

We live in an increasingly digital age. From logging on to virtual school, to accessing telehealth appointments, and to video calling loved ones, access to high-speed, reliable internet is no longer a luxury, it's a necessity. And for one in seven households in our district, the Affordable Connectivity Program (ACP) helps families save on their monthly internet bill.

The ACP was created by the Infrastructure Investment and Jobs Act, which I was proud to support when it passed the House last Congress. Unfortunately for the thousands of households in our community that depend on the program, it is set to run out of funding in April if Congress fails to act.
