# **Local School Districts to Receive** \$12 Million in Federal Funding

HARRISBURG - Rep. Joe Emrick (R-Northampton) announced today that school districts in the 137th Legislative District will receive nearly \$12 million in federal Elementary and Secondary School Emergency Relief (ESSER) funding as part of the federal Coronavirus Response and Relief Supplemental Appropriations Act (CCRSA).

"I am pleased that our local school districts are able to get this funding as it will allow them to continue to provide our children with an education, despite



the obstacles caused by this pandemic," said Emrick.

The funding for each school district is as follows:

Nazareth Area School District - \$1.45 million.

Easton Area School District - \$8.56 million.

Bangor Area School District - \$1.87 million.

As part of the CCRSA, Congress and the current administration established and appropriated a total of \$54.3 billion for the ESSER Fund. Funding is distributed to states based on each state's proportionate share of Title I, Part A (Title I-A) funding. ESSER funds are intended to support COVID-19 response efforts and may be spent on a wide range of allowable activities.

Pennsylvania's share of this funding is approximately \$2.22 billion, which will be distributed to the state's school districts and charter schools based on the Title I-A formula. This funding is on top of the \$471 million that was distributed to school districts last year through the CARES Act.

new minority businesses for certification and development through a new certification grant program, named after The GIANT Company, which will focus on food retail, consumer packaged goods, and support services companies. Disruptive Conduct Appeals Board - Vacancies are: Alternate Owner, Tenant, Alternate Tenant, Member of recognized community group Delegate and Alternate. This Board presides over any person aggrieved by any decision of a police officer or Building Official regarding a disruptive conduct report or the revocation of a residential rental registration or residential rental license based upon the issuance of disruptive conduct reports. It meets as needed.

• The Disruptive Conduct Board of Appeals shall be a body of five members consisting of a Council person who shall serve as Chairperson, the Chief of Police or his/her designee; an owner, operator, responsible agent or manager of a residential rental unit(s) in the Borough of Pen Argyl; an occupant of a residential rental unit residing in the Borough of Pen Argyl; and a member of a community group recognized by the Borough Council of the Borough of Pen Argyl.

#### Civil Service Commission- Three (3) Vacancies

- The Commission has the power to prescribe, amend, and enforce rules and regulations governing police appointments and promotions. In addition, the Commissioners hold appeal hearings on disciplinary actions,
- This Commission is presently dormant and does not have these powers as the Borough went to a Regional Police Force. However, it is the opinion of the Solicitor that we continue its membership.
