This week we recognized several important occasions across our nation. On Monday, we observed what would have been the 51st anniversary of Roe v. Wade. Over the last two years since the Supreme Court overruled nearly half a century of precedent, we have seen women in this nation be denied the care they need and subsequently suffer. ## Rep. Wild Announces \$40.8 Million for Lehigh Valley International Airport



This week, I was thrilled to announce a \$40.8 million grant coming to Lehigh Valley International Airport to help fund the construction of the Northside Logistics and Cargo Complex. This historic funding will improve the airport's ability to keep pace with current and future cargo processing. In 2023, the airport recorded its fourth consecutive year of record-breaking cargo processing amounts.

This grant was made possible by the Bipartisan Infrastructure Law, which I was proud to support last Congress and I was sure to write to Secretary of Transportation Pete Buttigieg in August to reaffirm my support of this project. Increasing accessibility to our region via air has always been a priority for me and in the past, I worked to secure \$5 million in funding for a Terminal Modernization Program and brought home \$600,000 in Community Project Funding for the airport's TSA Checkpoint and Terminal Connector project.

## Rep. Wild Advocates for Law Preventing Members of Congress from Trading Stocks

I believe that elected officials should work for their constituents, not for themselves. That's why I've joined 26 of my colleagues to urge a vote on a bill that would ban stock trading by Members of Congress, because no one should use their role as a public servant to get rich. This is a bipartisan issue, and I hope leadership will call a vote on this topic soon.
