## Grand Central Landfill to Postpone Community Meeting Nights

**Pen Argyl, PA.** March 13, 2020 – Grand Central Landfill announced today that the upcoming community meetings scheduled for March 18th at the Plainfield Township Fire Social Hall and March 19th at Wind Gap Fire and Lookout Fire social halls will be postponed for the health and safety of all residents due to the virus concerns.

“Health and safety for our employees and our community is our first priority,” stated Community Relations Manager, Adrienne Fors. “With the uncertainties of the Coronavirus (COVID-19), we are postponing our community meetings focused around our expansion plans until a later date.”

The community meetings were scheduled to explain the rezoning request previously submitted to Plainfield Township on February 19th and further explain the need to continue disposal operations at the facility.

Ms. Fors stated, “We are eager to share our plans with the community and will plan to do so once it is safe.”

## Effort to Boost EMS Ranks

BANGOR - It's no secret that many ambulance companies in the Commonwealth are struggling to recruit and retain enough emergency responders to keep their doors open.

To help address the problem, the Department of Health Bureau of Emergency Medical Services recently outlined regulatory exceptions that would allow individuals with lapsed certifications to more easily be reinstated.

From now through September 2021, any EMS provider whose certification expired on or after Feb. 1, 2010, may reinstate their EMS provider certification by completing one certification cycle worth of EMS continuing education, regardless of how many cycles their certification has been expired. Specific requirements for each type of certification are available here.

A second exception being made by the bureau says any EMS provider whose certifications have expired but have not been expired for more than one year will not be required to take the written examination previously required.
