# Sign the Jobs Bill!

BANGOR - Continuing our focus on ensuring #GoodJobs4PA, a bipartisan group of lawmakers joined organized labor and business leaders in both Harrisburg and Wilkes-Barre this week to call on Gov. Tom Wolf to sign legislation creating an Energy and Fertilizer Manufacturing Tax Credit.

Passed last month by significant bipartisan majorities in both the House and the Senate, House Bill 1100 was designed to encourage good-paying job and career opportunities – without the need of mandates, taxes or fees. Instead, the measure would



provide tax credits for building petrochemical manufacturing facilities in the northeast region of Pennsylvania. These facilities would then spur further investment in related businesses.

The bill mirrors a law that created the Pennsylvania Resource Manufacturing tax credit, which led to the Shell Cracker Plant investment in western Pennsylvania, a \$6 billion investment and the largest construction site in North America employing roughly 7,000 people daily.

If enacted, this tax credit would focus on large manufacturers using Pennsylvania methane in the production of ammonia, urea and methanol.
