

WILD IN REVIEW

First, I want to wish all who celebrate in our community a very happy belated Eid. I hope you and your loved ones had joyful celebrations. I firmly believe all members of our community should be able to practice their faith free from fear of violence, and I was deeply saddened to hear about the shooting at an Eid celebration in Philadelphia this week. I am praying for a swift recovery for all the victims. I was also deeply troubled by the bomb threat at the JCC in Allentown this week. I'm grateful everyone is safe, but this is the latest incident in a disturbing trend of rising antisemitism that must be stopped.

Finally, yesterday, our community received the news that Mack Trucks, one of the biggest manufacturers in our district, made the decision to open a plant in Mexico. For years, every Mack Truck built for North American roads was constructed in Macungie. I'm deeply disappointed that Mack has decided to end that tradition. I have been in contact with their leadership and they have assured me that Lehigh Valley Operations will remain its largest manufacturing facility. I have also made clear that it will be unacceptable for even a single job to be lost as a result of this decision, and I will continue to stand with the UAW workers in our district and across the country.



In Light of High Allentown Asthma Rate, Rep. Wild Calls for Lower Inhaler Costs

On Wednesday, I joined my colleagues to call on all pharmaceutical companies to lower the costs of inhalers to \$35 for American customers. Previously, three major drug companies announced they would cap the price of their inhalers at \$35, and it's time for the rest to follow suit.

I've fought to ensure all Americans have access to high-quality, affordable health care since my first day in Congress. One million Pennsylvanians deal with asthma, and Allentown has one of the highest rates of asthma in the country. We owe it to every child and adult who depends on their inhaler to ensure they aren't paying ten times more than other countries for the medical treatment they need.
