## **Supporting Math Nation for Local Schools**

Last week, I met with Glenn Zollman, director of state programs for Accelerated Learning and Math Nation, to discuss ways we can support Math Nation in Pennsylvania.

Math Nation is an interactive, supplemental math tool that fully aligns with Pennsylvania's Common Core State Standards for Algebra I, Geometry and Algebra II.

It offers schools a comprehensive set of resources including print workbooks to accompany its digital platform, a diagnostic intervention tool, unlimited night and weekend tutoring, ACT and SAT prep, additional teacher and family support, and ongoing implementation training from a Pennsylvania-based associate director.

Math Nation is helping to improve math achievement in states across the country—but currently, none of the school districts in the 138th District utilize the program.

I plan to send a letter of support for state funding and will be reaching out to our local school districts to encourage them to consider adding Math Nation to their curriculum.


The Pennsylvania House Legislative Fellowship Program is accepting applications for its fall 2025 semester.
