#### I-80 Expansion Project

No one enjoys surgery. It is painful and disruptive, but necessary to improve health. Infrastructure projects, like the I-80 expansion, are no different. They're inconvenient, but essential for long-term safety, efficiency, and sustainability.

Many of you have heard about this project over the years. As it moves forward, I want to provide a clear, factual overview. I also sat down with PennDOT Secretary Mike Carroll on my latest legislative report to discuss the importance and scope of the I-80 expansion.

Originally built to carry 10,000 vehicles daily, this section of I-80 now handles more than 80,000, including heavy truck traffic. It no longer meets modern de-



sign standards, and crash rates, especially near Exit 304 in Stroudsburg, are well above average.

This federally funded project will expand I-80 to three lanes in each direction between Exits 303 and 308. It also includes upgraded interchanges, extended ramps, safety improvements, and better traffic flow. Construction will begin in phases, starting with Exit 303, with bidding anticipated in June 2025.

Yes, the project may cause some disruption, but it should be minimized, as two lanes will remain open at all times – just as they are now. This once-in-a-generation investment addresses urgent safety needs and prepares us for future growth. You can watch my conversation with Secretary Carroll to learn more about what's ahead.
