PEER-TO-PEER PAYMENT APPS

With new technologies come new ways scammers are trying to steal our money. Peer-to-Peer (P2P) money sending apps – Zelle, Venmo, PayPal and the like – are popular ways for friends to send money back and forth. Unfortunately, scammers are using the same technology to receive payment from individuals they deceive into believing they owe money. These platforms have fewer consumer protections than other forms of payment. Use caution when sending money to people you do not know and watch out if a stranger insists on paying you via P2P apps.

NPS Announces Updated Regulations

BUSHKILL, PA- Where can I go camping? Where can I park my car for an overnight backpacking trip? Am I allowed to have a campfire? Which park trails allow bicycles? Where can I go with my dog?

All of these questions, and more, are answered in the recently updated Superintendent's Compendium of Designations, Closures, Permit Requirements, and Other Restrictions for Delaware Water Gap National Recreation Area. "Very little has changed from the previous version of the Compendium; however, the format of the document is slightly different than what people are accustomed to seeing," said Chief Ranger Eric Lisnik. "It's a good place to start when planning a trip to the park," he added. "Knowing what is allowed and where you can go to do certain activities is an important part of planning a safe and fun national park visit."

The Superintendent's Compendium addresses park-specific issues and regulations at the local level using federal authority granted to superintendents in Title 36 Code of Federal Regulations (CFR),

Parts 1 through 7. The CFR is a codification of the general and permanent rules published in the Federal Register by the executive departments and agencies of the federal government, including the National Park Service. The CFR is available electronically at www.ecfr.gov. Under 36 CFR 1.7(b), superintendents are required to "compile in writing all the designations, closures, permit requirements, and other restrictions imposed under discretionary authority. This compilation shall be updated annually and made available to the public upon request." Hotline to Assist Grandparents Raising Grandchildren

BANGOR - A new hotline to help connect thousands of grandparents who are raising their grandchildren to the resources and programs available to them is now live. The KinConnector hotline was established through Act 89 of 2018 to address the growing number of grandparents who have become primary caregivers to their grandchildren in the Commonwealth. It is a situation that has skyrocketed in recent years as a result of the state's opioid epidemic. An estimated 82,000 grandparents are the sole caregivers for nearly 89,000 grandchildren in Pennsylvania. KinConnector can be reached by calling 1-866-KIN-2111 (1-866-546-2111). The KinConnector helpline is staffed by social service professionals prepared to help families understand and access local, state and federal resources.
