

and many of our state parks offer swimming for our visitors," State Parks Director John Hallas said. "We welcome all visitors and encourage everyone looking to swim to plan ahead and check park websites for the latest updates on swimming hours, park capacity, and pool or lake closures."

Fifteen state parks have pools for the public to enjoy through Labor Day weekend. As a result of operational issues ranging from lifeguard shortages to Department of Health testing compliance, swimming schedules may vary.

Beaches at state parks are open and free to the public for swimming from before Memorial Day to after Labor Day, unless otherwise posted.
