

DEP Accepting Applications for Environmental Education Projects

The Pennsylvania Department of Environmental Protection (DEP) is now accepting applications for its 2026 Environmental Education Grants Program through Friday, Nov. 14.

Eligible applicants include public and private schools and universities, county conservation districts, nonprofit organizations and businesses. Projects must be implemented July 1, 2026, through June 30, 2027. There are three tiers of awards available: Seed Grants for projects up to \$5,000; Grow Grants for projects between \$5,001 and \$30,000; and Impact Grants for projects between \$30,001 and \$65,000.

A free webinar about the program will be held on Tuesday, Sept. 23, from noon to 1 p.m. Registration deadline is Monday, Sept. 22. Thursday, September 18 – 12:00 p.m. to 3:00 p.m. at the DHS Building

Participants must present a valid photo ID showing a Northampton County address in order to receive vouchers.

The Farmers Market Nutrition Program provides eligible seniors with vouchers that can be used to purchase fresh, locally grown fruits, vegetables, and herbs from participating farmers markets.
