## Rep. Wild Kicks Off Bipartisan Rural Health Caucus

WASHINGTON, D.C. – On Wednesday, Congresswoman Susan Wild joined lawmakers on both sides of the aisle to kick-off the Bipartisan Rural Health Caucus. The caucus provides a forum for Republican and Democratic lawmakers to work together to advocate for policy action to improve access to quality, affordable health care and mental health services for rural communities across the country.

"I'm excited to work with my colleagues, Republicans and Democrats, to address barriers to accessing quality health care in rural areas across the country," said Congresswoman Susan Wild. "Whether it's advocating for fair reimbursement rates for rural hospitals, or pushing to protect the 340B drug pricing program, I'll continue pushing to make sure that everyone—no matter where they live—can access the quality, affordable care they need to stay healthy."

Rep. Wild participated in a roundtable with caucus co-chairs Rep. Jill Tokuda (D-HI-02) and Rep. Diana Harshbarger (R-TN-01), as well as Rep. Glenn "GT" Thompson (R-PA-15), Rep. Carol Miller (R-WV-01), Rep. Andrea Salinas (D-OR-06), Rep. Nikki Budzinski (D-IL-13), Rep. James C. Moylan (R-GU-00), and Rep. Melanie Stansbury (D-NM-01). They were also joined by Carrie Cochran-McClain, Chief Policy Officer of the National Rural Health Association.

The group discussed these key rural health issues, what rural health care access looks like for people across the country, and areas caucus members can collaborate to improve rural health access: including expanding access to telehealth, strengthening the health care workforce, increasing fairness in hospital reimbursement policy, and more.
