Nominations Now Open Pennsylvania's 2026 River of the Year

Pennsylvania Organization for Watersheds and Rivers, or POWR, with funding from the state Department of Conservation and Natural Resources, is proud to announce the annual 'River of the Year' contest aimed to elevate public awareness of specific rivers, as well as recognize conservation needs and achievements. Nominations are accepted until 5 p.m. Nov. 21. After that, public voting begins.

Eligibility: All Pennsylvania water-

ways except for the past five winners of the River of the Year are eligible for nomination.

Last year, two Lehigh Valley waterways were nominated, the Delaware River and the Perkiomen Creek. The Delaware won.
