This program is a free service that provides Wills*, Living Wills, and Healthcare and Financial Powers of Attorney to first responders, and their spouses and partners.

If you die without a Will, Pennsylvania's intestate laws will determine who will receive your property. Undoubtedly, your loved ones' grief will be overwhelming; a clear expression of your intent, desires, and wishes may help ease some of this inevitable burden. While nobody likes to think about an untimely death, it is best that you express your wishes through a written document. For your family's peace of mind, please consider this invaluable opportunity, offered completely free to you and your spouse/partner.

On **Saturday, November 9, 2024**, volunteer attorneys will be conducting a **Wills for Heroes** program. This event will be held at the **American Legion Post 346, 126 East 5th Street, East Stroudsburg PA**. Each appointment lasts approximately 1 hour and at the conclusion of it you will have notarized legal documents – a Will, Living Will, and Health Care and Financial Powers of Attorney (or any combination thereof). Appointments are being scheduled from **11:00 AM to 4:00 PM**.
