Several weeks ago, I joined a bipartisan majority in the U.S. House of Representatives to pass a clean, nonpartisan government funding bill that would keep our government open. That nonpartisan bill has proceeded to the Senate, and while it continues to receive support from the bipartisan majority, some Senate Democrats are blocking it from receiving the 60 votes that are needed. This has resulted in a government shutdown.

As the shutdown continues, families across the Lehigh Valley and the Poconos are feeling the strain. I recently visited Second Harvest Food Bank to meet with staff and volunteers who are working tirelessly to keep food on the tables of families in need. Second Harvest is the region's largest network of food banks and serves as a critical safety net for thousands of residents.

The shutdown has made that mission harder. The Pennsylvania Department of Human Services recently announced that SNAP benefits will not be issued again until the federal government reopens. The shutdown isn't just a headline; it means empty pantries for families across the Lehigh Valley and the Poconos. With federal employees missing paychecks and food assistance programs halted, local food banks like Second Harvest are seeing increased demand.

## Here's what SNAP recipients need to know:

SNAP benefits will not be issued for November until the federal government is funded.

Any unused October benefits remain safe and can roll over into next month.

This poses a serious risk for tens of thousands of local families who rely on SNAP in order to put food on the table. The unnecessary and reckless government shutdown must end immediately. I continue to call on Senate Democratic Leadership to vote for the clean, bipartisan continuing resolution that will re-open the government and fully fund SNAP.

I also cosponsored H.R. 5822, the Keep Snap Funded Act of 2025. This legislation would ensure that families continue to receive SNAP benefits even during a government shutdown. This bill directs the U.S. Department of Agriculture to continue issuing benefits during a lapse in appropriations, gives the Secretary of Agriculture access to emergency funds to maintain SNAP operations, and allows the USDA to retroactively restore missed benefits once funding resumes. This commonsense legislation ensures no eligible family loses access to food because of political gridlock.
