Invisible Danger

When we perform a gas furnace inspection one of the parts we check is the heat exchanger. That is the part responsible for separating the air you breathe from the air that is going up the chimney. Because both of them are invisible it can be a difficult task. To add to the difficulty, most of the areas we need to inspect are not visible because of the way furnaces are made. We rely on a few different ways of testing to determine if the heat exchanger may be cracked. Usually when one test indicates a problem, we will use at least one other to verify the findings. Once we determine that there is a leak it is our duty to inform the homeowner and recommend replacement of the heat exchanger or furnace.

Carbon monoxide is deadly and even in low level cases causes drowsiness, listlessness, nausea and even vomiting. So many times these symptoms are blamed on the flu or a night at the bar, but staying at home for a day won't make them go away. It will keep you in a place where the poisonous gas is present and possibly make you worse. Another oddity of this killer is that it affects the young and the old sooner and more profoundly than healthy middle aged people. So

your mom or your baby may have symptoms and you feel just fine. Another problem is just like when your 42 year old son smokes weed in his basement bedroom while playing X-box, the air is distributed throughout the entire house thanks to the same furnace that creates the carbon monoxide. A low level carbon monoxide detector is a no brainer if you use gas for anything in the house. Even a gas water heater can cause a deadly problem because of the way most utility areas are built. There may be a water heater sitting right next to your furnace and if it develops a leak and the water drips on the gas burner inside, it will cool and disrupt the flame and create high levels of CO. And while all of the combustion gasses should go up the chimney, steam from one drop of water expands to about the size of a basketball and creates too much volume to fit up the chimney so it either spills out the draft hood or the bottom of the heater. It will be picked up by the furnace and distributed throughout the house. Take the advice of a CO expert when you have a gas appliance serviced.

Agriculture and Youth Organizations Grants

SLATE BELT - Youth organizations that promote agriculture and vocational training have until Nov. 29 to apply for state grants to help address a 75,000-worker deficit that Pennsylvania agriculture is expected to face in the next decade.

Eligible organizations include PA FFA, 4-H, Ag in the Classroom and others. Funds can be used for training, field trips, equipment and more. Eligibility requirements and applications for the Ag and Youth Grant Program are listed here.

Uses

Eligible projects include one or more of the following:
Education or workforce development seminars or field trips;
Agricultural safety training programs;
Capital projects or equipment purchases.

Eligibility

Agriculture and youth organizations are defined as any organization composed mainly of youth and organized to promote development in the areas of agriculture, leadership, vocational training, and fellowship. It includes, but is not limited to, Pennsylvania FFA, 4-H, Ag in the Classroom, Career and Community Leaders of America, and vocational education programs.

Funding

\$500,000 is available for grants for two different grant types that can be awarded under the program:

Direct, non-matching reimbursement grants of up to \$7,500 to defray costs of an eligible project, other than a capital project; and,
Matching reimbursement grants of up to \$25,000 to defray the costs of an eligible capital project or equipment purchase, where the grant covers no more than 50% of the project cost.
