I have open casework with your team, what happens now?
My team will continue to work on casework that has already been submitted to the relevant federal agency. If your casework has not already been submitted, a member of my team will reach out to you individually to assist you in transferring the case over to Senator Fetterman's team. What do I do if I have new casework issues arise before January?

I applied for a Military Academy Nomination, where does my application stand?

Our 2024-2025 Military Academy Nominations process will run as scheduled. Nomination interviews, selection and uploading will take place prior to December 31, 2024. Then, my team will pass nominee information to Congressman-elect Mackenzie so his team can continue the process. Beginning in January 2025, the Service Academies will update the nominee's portal to indicate who has received an appointment. If you have any questions on this process, please contact my office.

I applied for the Congressional App Challenge, where does my application stand?

Applications for the 2024 Congressional App Challenge have been received by my office and submitted for judging. A winner will be announced in December, and the winner will be eligible to attend House of Code 2025 in Washington, D.C.

I wanted to apply for the Congressional Art Competition, how will that competition be run?

The Congressional Art Competition is conducted in the spring in conjunction with the Baum School of Art. Congressman-elect Mackenzie's office will coordinate the 2025 Congressional Art Competition. Interested students should keep an eye out for information from the Baum School in March or April of next year.

I applied for an internship, where does my application stand?

I am grateful for the young people who have joined my team every semester for the past six years and have kept my office running. All applicants who had applied for a spring 2025 internship with my office will be notified that positions are no longer available. I strongly encourage all who applied to consider internship opportunities with my House and Senate colleagues who will be continuing their terms in the 119th Congress.
