State Budget Cuts Taxes, Funds Education

It's long overdue, but the state finally has a budget that invests in our schools, prevents tax increases, preserves services, cuts costs, and helps create jobs here in Monroe/Pike counties.

This budget also creates an important Working Pennsylvanians Tax Credit that will provide up to \$805 for those who claim the federal EITC. That's a cost-savings that is estimated to help almost 17,800 people in Monroe and Pike counties.
