The Y's land development is currently underway, with most of the construction occurring in spring of 2020.

David Fagerstrom, President and CEO of the Greater Valley YMCA shares, "This is an exciting moment for our community. It took patience and years of persistence, but I'm proud to see this full-facility expansion come to fruition. We are grateful for the Y's relationship with Waste Management and look forward to better serving the Slate Belt Community in the future."



The facility addition will allow the Y to serve more individuals through life-saving swim lessons, teens through the 7th Grade Initiative program, seniors through activities combating isolation, and children through education for their futures.

Adrienne Fors, Waste Management Community Relations Manager, added, "Our Grand Central team members are looking forward to utilizing the amenities that the expansion will soon include. We feel as passionate as the YMCA does about healthy lifestyles and feel that the amenities will be a nice addition to the Slate Belt."

The Y's Slate Belt Canvassing Committee is currently working to secure the rest of the necessary funding; pledging and naming opportunities are still available now. Once the project is completed, the YMCA will host a public grand re-opening / ribbon cutting to highlight the upgraded facility.

## Working Toward a Healthier PA

NAZARETH - This session, I was proud to join my fellow lawmakers in supporting several bills designed to remove barriers to treatment and to better assess behavioral health and other needs.

When dealing with cancer, time is of the essence. We in the House passed the Fair Access to Treatment Act (House Bill 427) to give Stage IV cancer patients easier access to alternative, innovative treatment options. Under current law, patients have to first fail on one FDA-approved drug consistent with best practices for Stage IV metastatic cancer treatment before another would be covered by their insurance. Instead, this bill removes that hurdle and would ensure cancer patients receive the best treatment available, as quickly as possible.

One of our caucus' major priorities is providing access to healthcare for those who would have otherwise gone without. Recognizing the need to help people seeking addiction treatment, I voted "Yes" on House Bill 1024, which would prohibit facilities from denying treatment to an individual based solely on a negative drug test.

Working to better understand our capacity to address behavioral health needs, our caucus introduced House Resolution 268, directing the Joint State Government Commission to study the impact of behavioral health treatment needs and behavioral health care system capacity on hospital emergency departments and patient health.

Finally, House Bill 1662 would require suboxone/buprenorphine-related deaths to be included in the Medication Death and Incident Review Act so any deeper issues can be addressed, such as a pill-pushing doctor or treatment facility.
