The communities in Bucks and Hunterdon County are just as outraged over the NJDOT Route 29 Devils Tea Table project as the communities in Warren, Northampton and Monroe Counties are over the proposed I-80 Rockfall Project at in the Delaware Water Gap. Route 29 is the protected National Delaware River Scenic Byway running along the protected Lower Wild and Scenic Delaware River. The scenic views and geologic unique Devils Tea Table rock formation is valued by the area just as Mount Tammany is valued in the Delaware Water Gap area. NJDOT rockfall plans promise to obliterate and permanently damage both.

Update - After not posting any updates on the I-80

Project website schedule since June 2020, an update showed up last week showing the project is delayed 2 more years. This delay been reported on by NorthJersey.com over the summer with a quote form NJDOT stating it was due to Native American Tribal Nations – Lenape requesting additional archeological studies.

We are not contesting that rockfall mitigation may be required in the project area. We are contesting that the proposed plan is rational, effective, or considerate of the harms that will result to our local citizens and environment.
