"There is more work to be done, I am looking at this rockfall mitigation, I feel here is another issue where our state government Is not focused. Our Governor's administration should be keeping his eye on the ball instead of letting his agencies run amuck. Spending \$65 Million, and maybe that cost be elevated from there, on a Rockfall project in our beautiful Delaware Water Gap...and the fact of it is it is not going to alleviate the problems in the S-Curve on Route 80 which is really the cause of all the accidents"

September 15, 2020 – Press Conference - Bi-State Elected Officials United to Preserve the Gap Really, who wants to see Tammany Mountain blasted into, it is such a special icon...We are all upset about it, those of us that wish to see the natural landscape preserved... it is a treasure of national significance. I have always felt you could cantilever 80 or find ways like they do out west, what, we are
