One winner will be selected from each school, in each grade. Winners and their immediate families will be invited to the Capitol to join me for lunch and recognition of their submissions.

Here's what you need to know:

- Open to all fourth and fifth grade students in the 138th District.
- Essays are due March 3, 2026, by 4:30 p.m. (must be postmarked by that date if mailing).
- Essays should be no more than one page, double-spaced, and can be hand-written or typed.
- Winners will be chosen by an independent panel of judges.
- One student from each grade at each school will be selected as a winner. Winners and their immediate family will be invited to the state Capitol in Harrisburg for lunch and recognition.
