

Banning Stock Trading by Members of Congress

Members of Congress are sent to Washington to serve their constituents, not themselves. We're here to work for you, and the last thing anyone in Congress should be focused on is their stock portfolio. That's why I'm proud to be an original co-sponsor of the Stop Insider Trading Act — a bill to ban stock purchases by members of Congress.

Do you support banning members of Congress from purchasing stocks?

From day one, I've pledged to work towards banning these purchases. Earlier this year, I also co-sponsored the Transparent Representation Upholding Service and Trust (TRUST) in Congress Act.

Now, this new bill brings us closer than ever to delivering reform: establishing clear penalties for purchases and requiring a minimum of one week's public notice before any already-owned stocks are sold. That means less abuse, more transparency, and a level playing field for investors.

I'll keep working to make sure that members of Congress play by the same rules as the American people.

The selected aide will work hands-on with constituents, assist with veterans' casework, and serve as a liaison between the district and federal agencies to help fellow veterans access the benefits and resources they've earned. Veterans honorably discharged within the last six years and eligible Gold Star Family members are encouraged to apply by January 30, 2026.
