On the Ground in Pennsylvania

On Friday, I spent the day in Lancaster County visiting two advanced manufacturing facilities that highlight Pennsylvania's leadership in innovation, skilled trades, and economic growth. I was able to bring my Dad with me throughout the day. We started in Lititz at Kenvue's manufacturing facility, a great example of Pennsylvania's life science history, where we toured operations and met with the skilled workers who produce trusted consumer health brands found in medicine cabinets across the country and around the world -- such as including Listerine®, Aveeno®, Neutrogena®, Lubriderm®, and Neosporin®.

During my visit to the 70-year-old plant, I saw firsthand how Kenvue is investing in America's advanced manufacturing by utilizing artificial intelligence (AI) in their production and data sourcing. I was also inspired by their Manufacturing Day initiatives that expose local high school students to rewarding careers in the skilled trades. It was impressive to see how this facility continues to innovate while supporting good-paying jobs for Pennsylvania families.

After a great tour of Kenvue, my team and I stopped at Dosie Dough in Lititz for delicious coffee and whoopie pies!

Then, we traveled to New Holland to tour Case New Holland's (CNH) agricultural equipment manufacturing facility, which has been producing machinery in Lancaster County for decades. We were able to meet with CNH's skilled workforce, many of whom are fourth-generation employees. This highlighted the company's deep roots in the community and its commitment to Pennsylvania's agricultural heritage and workforce. Having grown up baling hay and continuing to help maintain my family's farm, the visit was especially meaningful to me.

These visits in Lancaster County reinforced the importance of a strong domestic manufacturing base that creates great jobs, supports families, and keeps Pennsylvania competitive. With an incredible workforce, deep industrial heritage, and a culture of innovation, the Commonwealth is well positioned to continue leading America's manufacturing future.



KINDERGARTEN CLASS OF 2039

The Bangor Area School District (BASD) is excited to welcome the Class of 2039! The kindergarten team at Five Points Elementary School is looking forward to working with our new kindergarten class for the 2026-2027 School Year. A child is eligible for kindergarten if he/she

- is at least the age of five (5) years by August 31, 2026.
- resides within the boundaries of BASD.
- successfully completes the district's kindergarten registration process.

Kindergarten registration is online. Online kindergarten registration is available for parents and/or guardians through the district website (www.bangorslaters.com). Once packets are received and confirmed complete, BASD will contact parents/guardians to schedule a kindergarten screening appointment in June of 2026. Completed packets must be received no later than May 15, 2026, to guarantee a screening appointment in June. A completed registration includes:

- Parent/Guardian Photo Identification
- Proof of child's birth date (must be at least five (5) years by August 31, 2026)
- Two (2) proofs of residency
- Immunizations
- Physical Exam Record or proof of appointment prior to the start of school
- Dental Exam Record or proof of appointment prior to the start of school

To schedule a screening appointment, the completed online registration and mandatory documents must be submitted and approved by the registration secretary. Kindergarten screenings for the 2026-2027 School Year will occur in June of 2026. All screenings are by appointment only. An adult must accompany the child for their screening appointment. Our kindergarten staff is eager to meet and work with your child!

1. Parent/Guardian Photo Identification
2. Proof of child's birth date
3. Two Proofs of Residency

One proof from List A:

- Mortgage agreement
- Lease agreement
- Rent payment receipts (with address)
- Property tax payment receipts
- Moving permit

One proof from List B:

- Utility bill with current address (dated within the last 3 months)
- Paycheck stub with employer and employee's address
- Current voter registration with Bangor residency address
- PA Driver's license with Bangor residency address
- PA vehicle registration with Bangor residency address

5. Physical Exam Record or Proof of Appointment

6. Dental Exam Record or Proof of Appointment

Attend Screening Appointment

All screenings are by appointment only, and are only scheduled when the online registration process is complete and approved by the registration secretary. Completed packets must be received and approved no later than May 15, 2026 to guarantee a June screening appointment.
