


A Poem from the Archives of Donald Jones

Gov. Tom Wolf Orders All Pennsylvania Businesses That Aren't 'Life-sustaining' To Close, Will Enforce Order

HARRISBURG — Gov. Tom Wolf on Thursday announced that all but “life-sustaining” businesses in Pennsylvania must shut down immediately as the state braces for exponential increases in the number of people sickened by the novel coronavirus.

Unlike earlier in the week when Wolf urged nonessential businesses to voluntarily close the latest order came with a stern warning: those out of compliance as of Saturday 2/21/20 could face strict penalties.

Those businesses considered “life-sustaining” include grocery stores, gas stations, farms, and transit systems, according to the Wolf administration.

“To protect the health and safety of all Pennsylvanians, we need to take more aggressive mitigation actions,” Wolf said in a statement. “This virus is an invisible danger that could be present everywhere. We need to act with the strength we use against any other severe threat. And, we need to act now before the illness spreads more widely.”

The order takes effect immediately and will remain in place “until further notice.”

Hahn Temporarily Suspends Walk-In Services at District Office Over COVID-19 Concerns

WIND GAP – Rep. Marcia Hahn (R-Northampton County) today announced that her district office in Wind Gap will be temporarily closed to walk-in constituent services until further notice due to health concerns surrounding the novel coronavirus (COVID-19).

Hahn's staff will still be available to assist residents over the telephone or email with any state-related matter.

"Out of an abundance of caution, I have chosen to put on hold any services that would risk the health or safety of the public," said Hahn. "By this, I hope to help safeguard the wellbeing of my constituents—many of whom are senior citizens and, therefore, more vulnerable to this virus."

"Although my office will no longer be accepting walk-ins, my staff and I hope that constituents will continue to reach out through the available channels with any concerns they have. We are here to help in this difficult time and hopeful that regular services can resume shortly."
