STOP Insider Trading

This week, the House passed the bipartisan Stop Insider Trading Act, legislation I co-sponsored to prohibit Members of Congress, their spouses, and dependent children from purchasing individual stocks while serving in office.

The American people deserve confidence that their elected officials are making decisions based on what's best for the country — not their own financial interests. This bill helps restore trust by banning new stock purchases by Members of Congress, requiring advance public disclosure before the sale of covered securities, and establishing meaningful penalties for violations.

Since taking office, I've consistently supported efforts to increase transparency in Congress, including co-sponsoring the TRUST in Congress Act and the Restore Trust in Congress Act. While each bill takes a different approach, they all share the same goal: ensuring public service is about serving the people, not personal financial gain.
