Household Document Shredding Drop-off Events

EASTON - Lamont McClure and the Department of Public Works will hold two Household Document Shredding events, September 18th and October 16th, from 10:00AM – 12:00PM, rain or shine. The events are free and for Northampton County residents only. Paper waste will not be accepted from any business or organization.

Residents are limited to three boxes or bags per vehicle with a twenty-five pound weight limit per box or bag. Accepted items include accounting records, cancelled checks, pay stubs, financial statements, investment transactions, legal documents, medical records, tax forms, etc. Unacceptable materials include junk mail, magazines, catalogs, photographs, negatives and X-rays. Staples, paper clips, rubber bands and folders are okay. Ring binders, metal strips, and plastic sheet protectors or coverings will be refused.

Northampton County Thanks Troop 38 For Barred Owl Nesting Box Project

EASTON - Lamont McClure delivered a proclamation to representatives from Boy Scout Troop 38 at the August 5th County Council meeting for their troop project, installing two Barred Owl nesting boxes in the Minsi Lake Greenway in 2019. A pair of owls took up residence in one of the boxes this year, successfully raising two owlets which fledged in July. This may be the first account in the Northampton County



Parks system of Barred Owls using nesting boxes to successfully raise their young.

McClure and the Department of Parks and Recreation also thank the Hawk Mountain Sanctuary for their assistance with the installation and monitoring of Barred Owl nesting boxes. Dr. Jean-Francois Therrier, who has established a nesting box monitoring program at Hawk Mountain Sanctuary, banded the owlets.

“Northampton County is grateful to Troop 38 for beginning this project and to Hawk Mountain Sanctuary for assisting with the conservation efforts,” says Lamont McClure. “Our Parks and Recreation department will continue to protect our land and open spaces for both humans and wildlife.”

The Barred Owl is widespread in North America, living in forests and wooded swamps near to water. The raptor is known to feed on small mammals and amphibians. The birds mate for life and maintain the same territories and nest sites for many years.
