What 'Wood' You Do

I usually feel fortunate when I get hired to do complicated installation jobs. One reason is that they are challenging and require more planning and more skill than much simpler jobs but also because it shows a level of confidence that a customer has in my ability. I can't say that every one of those jobs has been perfect at the moment of completion but yet another reason that my company was chosen is because we will not abandon a customer if modifications are needed after the job is completed. We also get calls to make things right that were not installed correctly and the installer will not return to make the job work as promised. Most of the time those jobs just need some minor changes and nothing expensive but occasionally I see some real doozies.

Outdoor wood boilers have been gaining popularity over the last 10 or so years and for people with plenty of firewood available to them it can be a good way to provide heat to a home that uses hot water for that purpose. The manufacturers of the outdoor boilers don't provide much information about how to connect their equipment to what you already have in your home so many contractors just give it their best shot and most miss by a mile. Some manufacturers of gas and oil heating systems actually have diagrams and wiring instructions for how to connect a wood boiler to their system. That's helpful if they are followed. It isn't nearly as easy as it seems because you don't want to burn oil or gas when the wood boiler is hot and you don't want the house to go cold if the wood fire goes out. Controls are needed for that but that's where most jobs turn into a Frankenstein monster. I've probably repaired more installations than I have started from scratch but when things work properly it's seamless. When they don't work properly too many people abandon their large investment as something impossible to make work. I've even seen wood boilers that were kept burning all winter and never contributed an ounce of heat to the house just because they were installed wrong.

Having all the dirt and smoke outside is a good way to keep the house clean but getting that heat inside and getting the most out of it requires a little planning. That should start when the trench is still open but it can also start when the feeling of failure is coming on. It's never over until I say it's over.
