Tips for voting on Election Day

Casting a ballot at the polls

EASTON - On November 8, 2022, Northampton County's 154 precincts will be fully staffed for voters who prefer to cast their ballot on the ES&S ExpressVote XL machine. It is suggested that voters wear comfortable shoes and bring a chair if standing is difficult. Facemasks are recommended, but not required.

Polls will be open from 7:00AM - 8:00PM. Voters will check in at the registration table on an E-poll book by giving their name. The E-poll book will indicate if the voter is eligible to vote and if they are at the correct polling place. If so, they will sign in on the touchpad. First-time voters and voters who are voting in a new precinct may be required to show ID.

Voters who applied for a mail-in or absentee ballot and have turned it in are not eligible to vote at the polls.

Voters who applied for a mail-in or absentee ballot, but have decided they'd rather cast their vote on the machine must give the ballot and the return envelope to the Judge of Elections. After spoiling the ballot, the Judge will have the voter sign a Declaration to Surrender Ballot form. Only then will they be permitted to vote on the ExpressVote XL.

Voters who applied for a mail-in ballot, but do not have their ballot or the return envelope with them will be given a provisional ballot. The Elections Board will verify that the voter did not vote by mail before the provisional ballot can be counted.

Casting a mail-in or absentee ballot

The Elections Office reminds voters to carefully follow the instructions included with their ballot. "Naked" ballots—those which have not been enclosed in the inner secrecy envelope—will not be counted. The voter should use black or blue ink and

must sign and date the back of the return envelope. Mail-in ballots will be declared void if there are any identifying marks on the ballot or secrecy envelope.

If submitted by mail, the ballot must be received by 8:00PM on November 8th. Postmarks will not be considered. All return envelopes include postage; voters do not need to add a stamp.

On Election Day, mail-in ballots can be returned directly to the Elections Office located on the Lower Level of the Government Center at 669 Washington Street, Easton by 8:00PM, or at one of the County's four secure ballot drop-off boxes. The drop-off boxes have different closing times on Election Day. PA State Law states that voters must only drop off their own ballot. If you come into the Elections Office, you may be asked for your ID. If you drop off someone else's ballot you must have a "Certification of Designated Agent" form on file at the Elections Office. October Proclaimed Disability Employment Awareness Month

(WHITE TOWNSHIP, NJ. - October will be Disability Employment Awareness Month, the Warren County Board of County Commissioners proclaimed as they celebrated and recognized the capabilities and contributions of persons with a disability.

"There are all levels of abilities," Commissioner Director Jason J. Sarnoski said, adding the County supports efforts that "allow people to reach their full potential."

Receiving the proclamation were county Human Services Director Shawn Buskirk and Cynthia Wildermuth, Chief Executive Officer of the organization Abilities of Northwest Jersey Inc. Commissioner Lori Ciesla, who read the proclamation, noted that Abilities personnel "specialize in giving those with disabilities the ability to work. It makes a big difference in everyone's lives."

Commissioner James R. Kern III said Warren County is fortunate to have Abilities of Northwest Jersey and other organizations who work with people with disabilities, adding those groups are always looking for volunteers and donors to assist this important effort.

Wildermuth thanked the commissioners "for recognizing the critical need for employment for persons with disabilities." She noted the nation is currently at an all-time high – 38 percent – of employment of this segment of the population, "but we still have 62 percent of individuals with disabilities who may have that opportunity to succeed in life, we just have to get that awareness out there."

Each year, the month of October is designated nationally as "Disability Employment Awareness Month" to celebrate and recognize the capabilities and contributions of persons with a disability. In their proclamation, the Board of County Commissioners stated that it "recognizes that disability does not diminish the entitlement of any individual to live independently, enjoy self-determination, make personal choices, contribute to society and to experience the economic, political, social, cultural and educational mainstream of American society."

The County, through the Human Services department's Division of Aging & Disability Services and its Advisory Council on Disabilities, strives to create awareness and opportunities that "provide disabled residents and their caregivers the options and support needed to exercise their full rights as citizens in every component of our society and our County," the proclamation stated.
