### Pump It Up

I get asked fairly often what the difference is between an air conditioner and a heat pump. Most times people want the answer given in dollars but occasionally they want clarification on how the two units differ in operation. Technically they are both heat pumps because in air conditioning mode the heat is pumped out of the house and in heating mode it is pumped in. However, terminology has been standardized to mean that only units that pump heat into the house can be called heat pumps. There are only a few parts that need to be added to an air conditioner to make it a heat pump but you can't add them later. The indoor parts are usually the same between both units with the exception of added electric heaters in the heat pump system. Without the outdoor units ability to make heat efficiently the utility bills would be unreasonable for the entire winter using just the electric backup heaters.

The key to moving the heat in or out of the house comes from the refrigerant in the system. It is a mixture of chemicals and what makes it magical is the fact that it boils at a temperature well below 0°. We are used to thinking about water when we picture something boiling. Steam can carry a lot of energy, enough to turn a turbine in a power plant or operate a locomotive. When water turns to steam or steam condenses back to water, a large amount of energy is transferred. The same is true for refrigerant. The compressor in the outdoor unit creates pressure which heats up the refrigerant gas by mashing its molecules together. In the winter this heat is focused on the indoor coil where air is moving over it and it picks up the heat. The hot gas condenses into a liquid and returns to the outdoor unit where it is sprayed through a small orifice creating a drop in pressure. The pressure drop allows it to boil like water does in space but since refrigerant boils at -55°F even the coldest air we see in the winter will warm it up. It ends up as a cold gas and then goes back through the compressor and the cycle repeats. In air conditioning mode the vaporization takes place in the inside unit and the heat is released outdoors. Having the correct amount of refrigerant in the system is crucial for efficient operation. It can only be measured and adjusted correctly when outdoor temperatures are above about 60° so a summer checkup is best for all systems.

### Heating Assistance Program Opens Nov. 1

SLATE BELT - Residents who are struggling with their home heating bills can apply for assistance from the Low-Income Home Energy Assistance Program (LIHEAP) beginning Friday, Nov. 1.

LIHEAP is a federally funded program that helps individuals and families pay their heating bills through home heating energy assistance grants. It also provides crisis grants to help in the event of an emergency or if a resident is in danger of losing his or her heat due to broken equipment, lack of fuel or termination of utility service.

The income eligibility guidelines for LIHEAP are set at 150% of the federal poverty income level. For example, the income limit for an individual is \$18,735; for a couple, the limit is \$25,365; and for a family of four, it is \$38,625.

Residents may apply for LIHEAP online or by contacting the County Assistance Office in their county of residence.

## Use Caution: Deer on the Move

BANGOR - The Pennsylvania Game Commission is reminding motorists to slow down and stay alert for deer on the roadways.

Deer become more active in the autumn with the lead-up to their fall breeding season, commonly referred to as the "rut." Autumn also sees a number of people taking part in outdoor activities that might flush deer from forested areas or briar thickets, and deer are more actively feeding to store energy for winter months. Add to this the end of daylight saving time, which results in more traffic between dawn and dusk, and the chances of vehicle accidents with deer increase significantly.

Drivers can reduce their chances of collisions with deer by staying alert and better understanding deer behavior. Be especially alert in "Deer Crossing" areas, and remember deer tend to travel in family groups, so if you see one deer, more are likely coming.

To report a dead deer for removal from state roads, motorists can call the Pennsylvania Department of Transportation at 1-800-FIX-ROAD. If the deer is on a locally owned road, contact the appropriate municipality.
