## Public Comment On Minsi Lake Corridor Greenway & Stewardship Plan

EASTON - Lamont McClure and the Department of Parks & Recreation announce that the County of Northampton is seeking public comment on the draft of the Minsi Lake Corridor Greenway and Stewardship Plan. The consultant team of Simone Collins Landscape Architecture and Resource Environmental Solutions (RES) has completed the draft which addresses the compatibility of outdoor recreation with the conservation of environmentally sensitive lands.

The plan describes existing conditions, ecological resources, and recreational opportunities. Recommendations for infrastructure improvements, accessibility, ecological restoration, trails, and other passive recreational opportunities are provided. A climate change impact analysis lists the threats and vulnerabilities to the environmentally sensitive landscape within the Minsi Lake Corridor.

Public comment is open through Monday, December 20, 2021 on the DRAFT Minsi Lake Corridor Greenway & Stewardship Plan.
